Input from the Group on the Strategic Plan-

We wanted to gather community feedback for the recommendations section for our plan. The bulk of the data has been analyzed and now its what do you see in the community as the priority and the need. What's important to keep perspective on is that we have more people entering homelessness every year, them we see exiting-that is a huge problem. If we can't prevent folks from entering homelessness, that's a huge issue. Our system is already overrun. There is quite a bit of funding that flows into the homeless service system. We looked at local county funding, we looked at state funding and we looked at federal funding. The county wants us to look at all of these funding streams and make sure we are effectively using our money. For example, if the Community Development Office gets CDBG dollars and can use these dollars for service provision, then we can focus the Homeless Trust Fund money on vouchers. So we are looking for direction on is the type of housing models that work, what the barriers are that you are seeing in the community, and the different housing models that might be more effective so that we can make recommendations for how the funding should be utilized.

Connie Fahim-helping people stay in their homes is most effective. Employment, transportation is important to help stay in their homes. Barriers that might prevent people from being able to increase their income via employment that would help them stay in their home Kasey-what you are getting at is ancillary services that are out there like transportation, health care benefits, that we may not think of as being part of stability in housing. This is a critical piece in housing. OHP Diversion program includes these pieces.

Laurie Singer-employment programs-that would help people increase their incomes-CDL courses, etc.

Toi Collins-we are also seeing a lot of seniors that don't have the ability to increase their monthly income, so I think more permanent housing subsidies are severely needed.

Kasey-There are people who have the ability to increase their wages, but to Toi's point there are a lot seniors and people with disabilities who did

I will highlight that at the end of this week, our CoC Builds application is due that is for non-profit developers to apply for up to \$5 million in federal money to develop supportive housing Angelica Webber-can we get more funding into case management for

Angelica Webber-can we get more funding into case management for social services that would help with documents, transportation to get people to and from appointments, etc. There used to be a woman named Maria from OCBOSS who dropped off food baskets and helped out in other ways. There is a lack of affordable housing in Ocean County, can we foster relationships with landlords and motels.

Maria (senior services) – SS has not kept pace with increase in rent. It would be helpful if we could help seniors stay in their apts. A subsidy to help them subsidize their rent.

Kasey-Data has shown a need for prevention, particularly with these populations

Heather (BOSS)-Marie is still at BOSS, she is an aide and provides food baskets and other ancillary services when someone has in an emergency need. There are 4 other aides, as well. They requested funding for home repairs for Seniors.

Alan (DOE)- offer public service announcements, so that people know where to call. Maybe conversion of hotels into condos with a percentage them as supportive housing.

We will be putting together our recommendations for the strategic plan within the next month or so. And the plan will be shared out to the public once it has been approved.

Rose-the plan will go out in front of the Homeless Trust Fund and will put in front of the Board of Commissioners.
